- The NJ 2017 Homestead Reimbursement files are being released to Vendors and Municipal Tax Collectors.
- Reminder that Executive Order 220 prohibits the inclusion of water or electric delinquencies in Tax Sales through June 30, 2021.
- Daniel's Law is a work in progress. The implementation of the law has been extended to December 10, 2021. The Division is addressing the redaction of public information in both current and archived materials (i.e. Tax Duplicates)
