• Legislative

Chris Assenheimer, NJ League of Municipalities Legislative Committeeman, reported on the following:

- S-330: Increases distribution to municipalities from Energy Tax Receipts Property Tax Relief Fund over five years to restore municipal aid reduction; requires additional aid to be subtracted from municipal property tax levy.
- S-343: Increases, from 18% to 30%, amount of rental payments defined as rent constituting property taxes for purposes of deduction from gross income for property tax payments.
- A-1662: Allows shore municipalities to provide spouse and dependent children of veterans free or reduced cost access to beaches.
- A-1314: Requires municipality to return to taxpayer property taxes paid in error due to assessor's or owner's mistake.
- A-1327: Revises criteria to establish base year for homestead property tax reimbursement after relocation.
- A-2209: Increases annual income limitation for senior and disabled citizen's eligible for \$250.00 property tax deduction and bases future annual income limitations on annual CPI changes.
- A-3146: Increases contribution limit by counties and municipalities to volunteer first aid, ambulance, and rescue squads.

- S-399: Increases contribution limit by counties and municipalities to volunteer first aid, ambulance, and rescue squads.

Speaker Presentation:

John Hogan, Bergen County Clerk since 2011 presented an overview of the services of his office with an emphasis on Land Records Management, Deeds and Mortgages

- Bergen County Clerk's office is customer service oriented and technologically advanced.
- The Clerk's Office is the oldest elected Constitutional Office next to the sheriff and Surrogate
- Last year Bergen County Clerk's Office collected over \$20 million for E Recordings
- Passport Division handles Passports, photo ID cards for Firefighters, Veterans, Senior citizens, etc.
- Election Division (handled over 80,000 "Vote by Mail" ballots in 2021, up from 5,000 previously). Oversees the board of Elections
- Mr. Hogan addressed the questions posed by the BCTCTA regarding Deeds. A copy of the Questions and answers will be sent to those interested
- Land Record dating back to 1896 will eventually all be available electronically
