Treasurer's Report:

The Treasurer's Report was accepted. The ending balance at August 31, 2018 was \$16,725.48. Chita noted that there were 75 paid Business Associate memberships and 88 Regular members.

Next, Gennaro Rotella introduced our speaker for this meeting, Joseph Monzo of JP Monzo Consulting, LLC. He is also CFO of South Brunswick, Rocky Hill and Mansfield Township. Years prior, Mr. Monzo was the Acting Director of the Division of Local Government Services. The topic of the class was SALT, Senate Bill 1893. (Per Margie Sarharic, for SALT to work property, owners must pay a month before taxes are due.)

Committee Reports:

<u>Legislative:</u>

The legislative report was submitted by Chris Assenheimer, from a meeting held on June 22, 2018 at the Princeton Marriot Hotel and Conference Center. The report was read by Liz Villano.

Taxation and Finance:

- 1. S-2686/A4168: Permits 20-year leases for ferry boat and related facilities operation and maintenance and 50-year contracts with certain capital improvements, under "local Public Contracts Law". (Opposed)
- 2. S-2663: Requires Division of Investments to adopt rules governing investments of State-administered pension and annuity funds in real estate and infrastructure projects. (Opposed).
- 3. S-293: Concerns prevailing age payments in residential construction projects. (Opposed). S-2695/A4120: Authorizes special assessments and bond issuance to replace lead-contaminated water service lines. (Opposed).
- 4. S-2716/A4120: Authorizes special assessments and bond issuance to replace lead-contaminated water service lines. (Opposed).
- 5. A-3892: Requires that prior notice of tax sale be given to property owners. (Opposed).
- 6. A-3895: Requires percentage of alcoholic beverage penalties be forwarded to municipality. (Approved).
- 7. A-3954/S2551: Permits 20-year lease agreements for ferry boat and related facilities operation and maintenance under "Local Public contracts Law". (Opposed).
- 8. A-3957: Grants municipal courts discretion to assess court costs for certain dismissals. (Approved).
- 9. A-3984: Clarifies that property taxes are due and owing on tax-exempt real property leased to, or subject to, an operating agreement or management agreement with a person or business entity whose property is not exempt. (Opposed).
- 10. A-4038: Authorizes local contracting units to establish joint venture and set aside programs. (Opposed).
- 11. S-2645/A4173: Makes various changes to New Jersey Infrastructure Banks Enabling Act. (Approved).
